

ORDER OF ELECTION FOR THE CITY OF SOUTHMAYD

An election will be held May 4, 2024, for the City of Southmayd at the Southmayd City Hall, located at 4525 Elementary Dr, Southmayd, Texas for the purpose of: Electing one (1) Mayor for the remaining term of one (1) year and three (3) Aldermen for two (2) year terms each.


Application for ballot by mail must be received no later than the close of business on Tuesday, April 23, 2024.


