I request to take:

_____ a driving safety course _____ a motorcycle operator training and safety program

I have a valid Texas driver's license, number _____.

I **DO NOT** hold a **commercial driver's license (CDL)**.

I am not taking, and have not completed an approved driving safety course or motorcycle operator training course within the 12 months preceding the date of this offense.

I am not charged with speeding 25 or more mph over the posted speed limit.

I **have attached proof of financial responsibility** as required by the Texas Motor Vehicle Safety Responsibility Act. (Transportation Code Chapter 601).

I understand that:

- **acceptable payment for the court costs and fees, in the amount of One hundred fifteen dollars (\$115.00) are cash, credit/debit card, cashier's check or money order.**
- I have **ninety (90) calendar days** from today's date to complete an approved Driving Safety Course or Motorcycle Operator Course
- I am responsible for returning to this Court written proof showing that I have completed the Course and I hereby promise to present such proof by mail or in person no later than **ninety (90) calendar days** from today's date.
- I am required to obtain my driving record from the Texas Department of Public Safety and return that driving record to the court with my proof of completion of the Driving Safety Course or Motorcycle Operator Course.
- upon failure to comply with the **ninety (90) day** provision, I will be required to appear in the Court to SHOW CAUSE why I have failed to furnish proof of successful completion of an approved Course.
- my case **will not be dismissed** until the Court receives the following:
 1. **Original** completion certificate, **signed** by student for **Court: Grayson County JP3**.
Certified **Driving Record** from the Texas Department of Public Safety.
 2. Copy of proof of **insurance** coverage.
 3. Payment of **One hundred fifteen dollars (\$115.00)** for the court fee & court costs
- when I have completed the above conditions & have returned with proof thereof, the Court will dismiss. It will be noted on my driving record that I have completed a Driving Safety Course or Motorcycle Operator Course.
- the approved driving school will charge a fee for the Driving Safety Course or Motorcycle Operator Course.
- the **Court Fee/Costs** is non-refundable, whether or not I complete the Driving Safety Course or Motorcycle Operator Course.
