7. You can PLEA NOLO CONTENDERE (NO CONTEST) to the charge and pay the fine and court costs in this matter. On a PLEA OF NOLO CONTENDERE, the court will find you guilty of the charge and accept your payment
8. You can PLEA NOT GUILTY, to the charge and have an attorney. And a trial date will be set for you to plead you case before the court.

PLEA OF NOT GUILTY

SHOULD YOU BE FOUND GUILTY, YOUR FINE WOULD BE IN THE AMOUNT NOT TO EXCEED \$ _____ PLUS COSTS PER VIOLATION.
