Kids Hurt Too Divorce Education Seminar

Held in Grayson and Fannin Counties

The Kids Hurt Too Divorce Education Seminar started in 1997 in Grayson County due to the District Judges' heartfelt concern for the well being of children of divorce. Since that time thousands of parents have attended the seminar. In 2003, the program expanded to the 6th Judicial District Court and 336th Judicial District Court in Fannin County. In the fall of 2008, the 397th Judicial District Court was added to Grayson County. The seminars are facilitated by licensed mental health professionals.

The standing order reads, in part: the parties are ordered to successfully complete said seminar within sixty (60) days of either the filing of the petition or motion to modify or the receipt of notice of the petition or motion, and prior to any final hearing.

It is our privilege to work with the district court judges in Texoma to help divorcing parents understand the impact divorce has on their children and how they can avoid placing their children in the middle.

Seminar Survey comments from 2011 parent participants...

- *To see things from my daughter's eyes. I think we get caught up in our own depression and anger. Kids do hurt too but don't show their feelings like adults.*

- *It gives you the chance to check yourself as a parent.*
