Initial _____ a driving safety course a motorcycle operator training and safety program (choose one)

Initial _____ I have a valid Texas driver's license, number _____.

Initial _____ I **DO NOT** hold a **commercial driver's license (CDL)**.

Initial _____ I am not taking, and have not completed an approved driving safety course or motorcycle operator training course within the 12 months preceding the date of this offense.

Initial _____ I am not charged with speeding 25 or more mph over the posted speed limit.

Initial _____ I **have attached proof of financial responsibility** as required by the Texas Motor Vehicle Safety Responsibility Act. (Transportation Code Chapter 601).

Initial _____ I **have attached a cashier's check or money order in payment of the court costs and fees, in the amount of One hundred fifteen dollars (\$115.00)**.

Initial _____ I understand that I have **ninety (90) calendar days** from today's date to complete an approved Driving Safety Course or Motorcycle Operator Course.

Initial _____ I am responsible for returning to this Court written proof showing that I have completed the Course and I hereby promise to present such proof by mail or in person no later than **ninety (90) calendar days** from today's date.

Initial _____ I understand that I am required to obtain my driving record from the Texas Department of Public Safety and return that driving record to the court with my proof of completion of the Driving Safety Course or Motorcycle Operator Course.

Initial _____ I understand that upon failure to comply with the **ninety (90) day** provision, I will be required to appear in the Court to **SHOW CAUSE** why I have failed to furnish proof of successful completion of an approved Course. I further understand that my case **will not be dismissed** until the Court receives the following:

- This **Affidavit**.
- **Original** completion certificate, **signed** by student for **Court: JP3, M Reeves**.
- Certified **Driving Record** from the Texas Department of Public Safety.
- Copy of proof of **insurance** coverage.
- Payment of **One hundred fifteen dollars (\$115.00)** for the court fee and court costs.

Initial _____ I understand that when I have completed the above conditions and have returned with proof thereof, the Court will dismiss my traffic citation and the violation will not appear on my driving record. It will be noted on my driving record that I have completed a Driving Safety Course or Motorcycle Operator Course.

Initial _____ I understand that the approved diving school will charge a fee for the Driving Safety Course or Motorcycle Operator Course.

Initial _____ I understand that the **Court Fee/Costs** is non-refundable, whether or not I complete the Driving Safety Course or Motorcycle Operator Course.
