You may be able to require that this charge be dismissed by taking a Driving Safety Course. However, you will lose that right if you do not provide written notice to the court on or before your appearance date of your desire to do so. Some exceptions may apply. Contact the court for additional information.

IF YOU WISH TO ENTER A PLEA OF GUILTY OR NOLO CONTENDERE:

Please refer to schedule shown on the reverse side of this letter to determine the total amount of the fee(s) required and indicate your pleas in the proper space provided. Make your remittance by Cashier's Check or Money Order. Return your copy of this letter to the above address with your remittance to assure proper credit.

IF YOU WISH TO ENTER A PLEA OF NOT GUILTY:

You must contact the above court in writing or by appearing in person no later than the appearance date shown on the citation. You shall be notified by mail of your court trial date.

If you fail to respond to this charge by the appearance date shown on the citation, an additional charge may be assessed against you for violating promise to appear and warrants issued for your arrest with additional costs. Additional fees may apply for partial payments.
