

**ORDER DECLARING UNOPPOSED CANDIDATES AND  
CANCELLING THE MAY 3, 2025, GENERAL ELECTION**

**(ORDEN QUE DECLARA CANDIDATOS SIN OPOSICIÓN Y

**WHEREAS**, THE CITY COUNCIL OF THE CITY OF VAN ALSTYNE, GRAYSON COUNTY, TEXAS, ON FEBRUARY 11, 2025, DID DULY ORDER A MUNICIPAL ELECTION TO BE HELD ON MAY 3, 2025 TO ELECT TWO (2) ALDERMEN; AND

**ALDERMAN PL 4 – CARY “LEE” THOMAS**
