INSTRUCTIONS FOR COMPLETING AN AFFIDAVIT OF ABSENT APPLICANT FOR MARRIAGE LICENSE

The attached Affidavit of Absent Applicant is to be used to apply for a Marriage License when one party is unable to appear in the County Clerk's office. Please read the following instructions carefully before completing the affidavit.

- 1. The party who will **not** be able to appear before the Clerk must complete and sign the Affidavit of Absent Applicant for Marriage License form.
- 2. The names of both parties must be printed exactly as they appear on the identification used to obtain the Marriage License.
- 3. If absentee applicant is unable to attend the wedding ceremony because he/she is a member of the Armed Forces of the United States stationed in another country in support of combat or another military operation, he/she must name a proxy. This person need not be present to apply for the license, but they must appear at the ceremony. The proxy can be male or female and must be 18 years or older.
- 4. The other party must then appear in the County Clerk's office at least 72 hours, but not more than 90 days prior to the ceremony. They must present:
 - A. The completed and **notarized** Affidavit of Absent Applicant.
 - B. An acceptable form of identification for both parties that states the correct name and date of birth of each applicant. This may include any of the following:
 - 1. Valid driver's license (If providing a photo copy please have it notarized)
 - 2. Valid passport
 - 3. State issued ID card
 - 4. Military ID card
 - 5. Certified copy of birth certificate

NOTE: The ID for the absent applicant may be a legible photocopy. The ID for the party appearing before the Clerk must be original.

- C. Each party must know their Social Security number.
- D. An altered document will not be accepted as proof of identity.
- E. The fee for the marriage license is \$71.00 cash, check or credit card. (American Express not accepted.)

AN AFFIDAVIT OF ABSENT APPLICANT FOR MARRIAGE LICENSE EXPIRES 90 DAYS FROM THE DAY OF SIGNING. IF THERE IS A CHANGE IN PROXY, THE PROCESS STARTS OVER.
