#### Helicopter interior manufacturer relocates to North Texas Regional Airport

DENISON, Texas (February 16, 2018) – AMS Heli Design, LLC has relocated headquarters from Grand Prairie Municipal to North Texas Regional Airport to accommodate growth.

AMS specializes in the design, manufacturing, and installation of lightweight emergency medical services (EMS) interiors in helicopters. The helicopters are primarily used rescue missions and hospital transportation along with other important applications such as neonatal transport.

Chief Executive Officer Andrea Girolin said they selected North Texas Regional because of its location and growth potential.

"The airport position is very strategic because it is close to Dallas but not in the highly congested area," Girolin said. "It offers a possibility for hangar expansion which is very important to us as we grow."

AMS will begin operations with conservative expectations to complete six to eight helicopters in 2018.

"We're looking forward to seeing AMS grow here at North Texas Regional," said Grayson County Regional Mobility Authority Chairman, Robert Brady. "With the help of Texas Aviation Partners, we were able to demonstrate the airport's unique position and value in a competitive market."

In January, AMS announced the receipt of a Federal Aviation Administration (FAA) supplementary type certificate for a new lightweight and quickly removable emergency medical services advanced life support system (ALSS) interior for Leonardo AW119 and AW109 helicopters.

The interior has been selected by the South African Red Cross to be installed on three of its aircraft with plans to retrofit an additional five helicopters over the next two years.

"With the expected certification of two additional helicopters in 2019, we anticipate our deliveries to significantly increase, possibly double, in the next two years," said Girolin. "AMS is in the business of saving lives with our advanced technology aircraft EMS interior designs and manufacturing, and we're happy to have found North Texas Regional and Grayson County to support our mission."
