

RESOLUTION NO. 2026- 003

**RESOLUTION OF THE COMMISSIONERS COURT OF GRAYSON COUNTY,
TEXAS APPROVING FIREWORK SALES DURING SPECIFIED HOLIDAY
PERIODS**

WHEREAS, the Commissioners Court of Grayson County, Texas, is empowered under the Texas Constitution, the Texas Local Government Code, and Texas Occupations Code Chapter 2154 to govern county affairs, regulate public services, or regulate the sale of fireworks; and

WHEREAS, the Fire Marshal has presented the annual fireworks selling seasons for 2026 for consideration; and

WHEREAS, the Court has identified a need to approve said selling periods to ensure compliance with legal standards, protect public welfare, or address community concerns; and

WHEREAS, consultation with the Fire Marshal supports this action; and

WHEREAS, the Commissioners Court deems it necessary to approve the fireworks sales periods;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS COURT OF GRAYSON COUNTY, TEXAS, THAT:

SECTION 1. The sale of fireworks is hereby authorized during the following periods, subject to any existing burn bans or emergency declarations:

1. Lunar New Year: February 12, 2026, through midnight, February 17, 2026
2. Texas Independence Day: February 25, 2026, through midnight, March 2, 2026
3. San Jacinto Day: April 16, 2026, through midnight, April 21, 2026
4. Memorial Day: May 22, 2026, through midnight, May 25, 2026
5. Juneteenth: June 14, 2026, through midnight, June 19, 2026
6. Independence Day: June 24, 2026, through midnight, July 4, 2026
7. Diwali: November 3, 2026, through midnight, November 8, 2026
8. New Year's Eve: December 20, 2026, through midnight, January 1, 2027

SECTION 2. The County Clerk is directed to record this resolution, notify affected parties, or publish notice in accordance with applicable law.


SECTION 3. Relevant parties are notified that sales during these periods are subject to any burn bans in effect or emergency declarations issued by the County Judge.

SECTION 4. This resolution shall take effect immediately upon adoption, and the County Clerk shall ensure its recording in the official minutes and publication or distribution as required by law.


